Mr. Cromeans mentioned if the property on Irwin lane could be buildable upon for tax revenue. Commissioner Dan Giebel stated it could be. This would be private property not to be voted upon by the township. Has complaints about the garage on E. Beckert and its horrible condition. Manager Kaib stated that the Magistrate gave the owner 60 days to comply. Mr. Cromeans would like the POW flag at the firehouse to be replaced.

<u>Dave Fischer 215 Karen Dr-</u> Stated he met with our Solicitor at the last meeting and is looking for a letter about the pipe on his property. Solicitor Nate Boring said he will be sending him a letter.

<u>Tom Latwin 107 Arlington St-</u> is asking for the profit made from the sale of the dump trucks. Manager Kaib did not have those figures in front of him but said he will call him with the information. Also stated he heard a rumor about PWSA taking over reserve water Line. All the commissioner commented that this has been said for the last 10 years but nothing has been done.

<u>Ken Vybiral 2439 Arlington</u>- stated that at the top of Ampere Street, there is a water leak which makes the rain very icy and dangerous in the winter for the children walking to the bus stop. Manager Donna Kaib will address.
