Ken Vybiral 2438 Arlington St: (Question emailed to Township)

Amber Villella 432 Irwin lane: (Question emailed to Township)

1. County Hauling is consistently late in picking up trash and recycling, what is the issue? Manager Kaib said we have been in close contact with County Hauling about the misses in the township, they stated it has been due to loss of employees. Manager Kaib commented on maybe having a representative come to one of the public meeting to address these issues with the residents.

2. Is Reserve Twp. planning or required to raise funds for the Girtys Woods? Manager Kaib stated this has not been discussed amongst the board members at this point. The board stated they are not in agreeance to solicit the township residents for money for this project. That is privately owned and has nothing to do with the township.

3. Amber stated she has lived on Irwin lane and speeding has been a constant issue. With only one speed limit sign on this street she was looking to get more signs and a possible speed hump installed to deter this speeding. Commissioner Nuerohr stated speed humps are illegal to put on as residential street and he does not think another speed limit sign would help due to the fact the speeders ignore the first one. He did mention a higher police presence and maybe some citations or warnings on the speeders.

A letter was written to the township concerning the junk yard and their operation. Commissioner Nuerohr stated he appreciated the letter and concerns; we are looking into these same concerns as we speak.
