
## NEW ORDINANCES:

### **EFFECTIVE IMMEDIATELY**

**IF YOU ARE DELINQUENT OR CAN NOT PAY YOUR WATER BILL, CALL THE OFFICE IMMEDIATELY FOR RESERVE TOWNSHIP TO ASSIST YOU WITH PAYMENT ARRANGEMENTS.**

**NO PAYMENT ARRANGEMENTS WILL BE MADE ONCE YOU RECEIVE THE SHUT OFF NOTICE. PAYMENT WILL NEED TO BE PAID IN FULL. NO EXCEPTIONS**

### **NOTICE TO LANDLORDS AND TENANTS**

**No water bill will be put in a tenant's name unless;** a billing change request form is filled out by the owners of the property, an application for sewer and water service is completed, and a \$200.00 security deposit is received.

All forms can be found on the Township Website and in the Township office.

Note: This does not release the owners from delinquent bills. Owners are still responsible for any & all outstanding bills not paid by tenants.

## **HYDRANT FLUSHING**

The Township will be doing routine flushing of the water lines during June, July, and August. This process can cause your water to turn brown temporarily. Please be sure to check your water before doing wash or other cleaning. If this should occur, run your water for a few minutes until the water becomes clear.

### **Attention Landlords, Homeowners, Managers, and Tenants**

Reserve Township requires, by Ordinance #608, that all owners, landlords, managers, and agents **MUST** register all tenants/renters from all properties located in Reserve Township. Occupancy is required for new tenants. Forms are available at reservetwp.com or at the Township Office.



## NOTICE TO ALL RESIDENTS

Do you have an accumulation or dumping of automotive junk, boats, abandoned and dilapidated vehicles, tires, other vehicle parts and components?

Do you have obnoxious vegetation, dumping of rubbish, garbage, water materials, debris, litter, junk, etc. in your yards?

This can constitute a nuisance, hazard and menace to the health, safety and welfare of our township and a breeding ground for insects, mosquitoes, rodents, or other vermin!!

**IF SO, RESERVE TOWNSHIP IS ALLOWING UNTIL  
JULY 31, 2021, TO CLEAN IT UP!**

After July 31, 2021, homeowners will be given a citation and fines of up to \$1000 will be issued to all houses violating Ordinance #583.

**HELP KEEP RESERVE TOWNSHIP BEAUTIFUL**

**This is the time of year that the township receives calls from residents complaining about high grass. Per Ordinance #583 homeowners must maintain their grass and other obnoxious vegetation. Please be courteous. Failure to comply will result in a citation. Code Enforcement will be monitoring the township.**



### **Reserve Township follows Allegheny County Health**

**Department's Open Burn Regulations. No material other than clean wood, propane, or natural gas may be open burned EXCEPT for:** \* Commercially available fire logs, paraffin logs, or wood pellets. \* Paper or commercial smokeless fire starters to start a fire. \*Charcoal for the preparation of food only.

**Fires may be no larger than 3' wide by 3' long by 2' high.**
