1. Seeking approval for a Mutual Aid Agreement for Salt through the North Hills Cog from September of 2021 to August of 2022 at \$72.83 a ton. Commissioner John Kaib made the motion for approval, with a second by Commissioner Ed Vincent. All in Favor
2. CDBG 4year Grants approved. Arlington Street Storm Drainage Improvement awarded \$127,764.00. Karen Drive Storm Sewer Improvement awarded \$131,307.00.
3. Applied for a grant for The American Rescue Plan Act which was approved in the amount of \$337,558.20. Commissioner Nuerohr commended Manager Kaib on her efforts to obtain this grant in the short time they allowed.
4. Penn Dot notified us of work to be started on Geyer Rd from the intersections of Mt Troy Rd to Babcock Blvd, starting August of 2021 and ending in November of 2021. Work to take place during the day and nighttime hours.
