- 1. Ms. Thiess reported the 2021 Audits for the Financial Books and Liquid Fuels Funds were recently completed with no findings to report.
- 2. PennDOT will Tar & Chip Geyer Rd, Lonsdale St to Wickline's Lane and Williams Rd. The State will post signs prior to the work being done.
- 3. Allegheny Land Trust has notified the Township regarding a possible acquisition of the Pavkovic property (46.24 acres) on Geyer Rd Extension. They are applying for funds through the DCNR.
- 4. Possible upcoming conditional use hearing by the Planning Committee allowing Star Automotive use from "garage" to "warehouse." The Township is waiting for the application from the property owner.
- 5. Ms. Thiess attended the Municipal Intern Fair which was only open to University of Pittsburgh students resulting in a limited amount of intern prospects. Other local universities may need to be contacted to help fill the intern position.
- 6. Allegheny County originally dropped the Township's Year 47 project but after receiving a persuasive letter, the County has decided to almost fund the Karen Drive project fully, saving the Township around \$140,000.

PUBLIC COMMENTS ON AGENDA ITEMS

Dan Cromeans - 2101 Lonsdale St.

Referring to the Wireless Towers Zoning Amendment, Mr. Cromeans questioned if there is interest in putting a new cell tower in the township. There are no current inquiries regarding placing a new cell tower in the area.

Tom Latwin- 107 Arlington St.

Questioned when the Arlington sewer project will begin. Manager Thiess stated no definite date has been given due to a backorder of supplies.

Ken Vybiral 2439 Arlington St.

Inquired as to how the Township decides which roads will be paved citing the poor condition of the top of Arlington. Manager Thiess stated the Township is developing a paving schedule and the roads are currently being rated and measured to obtain estimates for budgeting for a future paving schedule.

Jackie Cromeans-2101 Lonsdale St.

Asked about the legal process of converting a single-family home into a two-family unit in reference to property currently for sale in the Township. Commissioner Sweeney and Solicitor Boring explained that changing the use would require the zoning process.
