TOWNSHIP OF RESERVE REGULAR MONTHLY MEETING May 15, 2023

CALL TO ORDER

Commissioner Neurohr called the meeting to order on May 15, 2023, at 7:00 PM.

ROLL CALL

Indicated Commissioner Sharon Sweeney, Commissioner Ed Vincent, Commissioner John Kaib, Commissioner Ron Neurohr, Manager Jan Kowalski, Solicitor Nate Boring and Engineer Gordon Taylor were all present. Also present were approximately 20 visitors.

EXECUTIVE SESSION

Commissioner Ron Neurohr reported the Board of Commissioners held an Executive Session tonight at 6:00 pm., wherein the following topics were discussed: employment and personnel matters, contracts and policies, actual and ongoing litigation as well as potential litigation and identifiable complaints.

PUBLIC COMMENTS-

Jim Maloney -25 Arlor Dr - Mr. Maloney is requesting a time frame for when he should expect the repairs to be made to his driveway from the paving done last year. Manager Kowalski stated that she would reach out to him after speaking with Public Works. Mr. Maloney also spoke on behalf of his neighbor regarding her driveway that was not repaired after a water main break.

Dan Cromeans – 2101 Lonsdale St. – Mr. Cromeans stated that the loose gravel needs to be cleaned up on Lonsdale and Manager Kowalski stated that she has been in contact with the County and many streets are on list to be cleaned up and she will follow up with them. Mr. Cromeans stated that there is a water leak in Pearl Alley, and the asphalt curb is now falling apart. Manager Kowalski stated that she would bring it to the Foreman's attention. Mr. Cromeans raised concerns with PWSA and the rate increase that they advertised. Mr. Cromeans raised concerns about putting in a holding cell built by the Public Works Crew.
