## UPDATE ON RESERVE TOWNSHIP WATER AND WASTEWATER OPERATIONS

As everyone knows by now, the Reserve Township Board of Commissioners signed a joint agreement with Pittsburgh Water and Sewer Authority (PWSA) to take over Operations and Maintenance of our water and wastewater systems. The agreement was submitted to the PA Public Utility Commission (PUC) for approval in August 2023. Our expectation was that the review process would take about 30 days and that we would be well into the transition by this time.

After eight months of meetings and discussions with the PUC, the Commission ordered on April 25, 2024, that the case be assigned to the Office of Administrative Law Judge for Alternative Dispute Resolution. This order was based on the Commission's determination that the terms of the agreement may benefit Reserve Township customers to the detriment of PWSA's other customers. At this point we would be facing a lengthy and expensive process with no guarantee that the Agreement would be ultimately approved. Needless to say, we are all disappointed.

When we entered into this Agreement, neither Reserve Township nor PWSA anticipated there would be any objection to the terms. On Reserve's side, we negotiated in good faith what we thought would be the best deal for our customers, including new advanced technology water meters at no cost to the customer. The PUC obviously objected to this. Under the circumstances, we have decided to place the process on hold.

For now, it will be "business as usual" for our water and wastewater customers. Billing and collections will continue to be done by Township office staff, and repairs will still be performed by our Public Works crew. We regret that we will not be able to implement the upgrades we promised under the new Agreement, like new wireless water meters that can be read remotely, monthly billing and automatic bill pay options. As always, thanks for your patience while we continue to explore other options.

### ARE YOU SELLING YOUR HOME? DO YOU HAVE A NEW TENANT MOVING IN?

Here are the things that you will need to have completed before selling your home:

- Occupancy Certificate, call the Township Office and schedule an appointment with our Code Enforcement Officer
- Dye test, completed by a certified plumber
- Municipal Lien Letter
- Final Read will be completed 2 days before closing.

**A Property Registration form will need to be completed for all new Tenants.**
